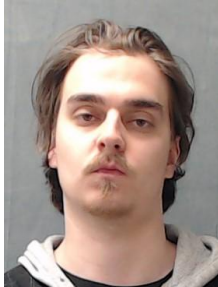
Warrant Service

Driving Under the Influence

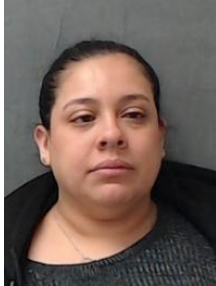

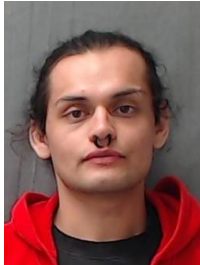
Theft
