Driving Under the Influence of Alcohol

At 7:04 p.m. an officer was dispatched to 7516 Cass Avenue, Walgreens in reference to an individual asleep inside a running vehicle. The officer observed an open alcoholic beverage in the vehicle. Leo Garfias-Felipe, 54, of the 6400 block of Woodward Avenue, Downers Grove, was transported to the Darien Police Department and charged with two counts of driving under the influence of alcohol. Garfias-Felipe was issued a court date of September 1, 2026 at the DuPage County Judicial Center.
