October 1

Domestic Battery

An officer responded to the 7500 block of Farmingdale Drive for a domestic battery. Meliki Scanlan, 18, of the 7500 block of Farmingdale Drive, Darien was charged with two counts of domestic battery. Scanlan was transported to DuPage County Jail by Darien Police.



Retail Theft

Theft from Motor Vehicle

The person proceeded to get into the passenger side of another vehicle and get in. The vehicle jumped the curb and fled the scene. Estimated loss \$300.
